**ORDER**

Government had approved the Prospectus for MTech Regular Course for the academic year 2022-23 as per the Government Order read as 6th paper above. The M.Tech Sponsored Quota Reservation as per



Clause 3.2.1 and 3.2.2 of Government approved M.Tech Prospectus for the year 2022-23 is as follows.

***Seats Reserved for Sponsored candidates (special reservation):-***

***Clause 3.2.1.*** The following seats are reserved for P.G admission under sponsored candidates' quota as per the existing Govt. orders.

***Clause 3.2.2. Guidelines for Govt. sponsored candidates:***

Maximum of 10% seats in each specialization is earmarked for the candidates sponsored by any other Central/State Govt. and Public sector undertakings on merit basis as per clause 6.3. The candidates should get the Government order from Higher Education Department



*for eligibility of such sponsorship. The Govt. orders in this regard should officially reach the office of Directorate of Technical Education on or before the last date of application. Maximum seats allotted for sponsored candidates will be limited to two per sponsoring Department, and should not exceed 10% in each branch/specialization of an institution. These candidates should fulfill the criteria of eligibility of admission clause 4.*

As per the letter read as 7th paper above, KWA Managing Director had requested to restore five MTech Sponsored Quota seats for the sponsored candidates of Kerala Water Authority including 3 seats allotted to PHED - Public Health Engineering Department vide Government Order read as 1st paper above and 2 seats allotted to Kerala Water Authority vide Government Order read as 4th paper above, for Civil Engineering.

As per the letter read as 8th & 10th paper above, Chairman, Kerala State Pollution Control Board had requested to restore the two MTech Sponsored Quota seats for the sponsored candidates of Kerala State Pollution Control Board allotted vide Government Order read as 2nd & 3rd paper above.

Government examined the matter in detail and are pleased to accord sanction for two Sponsored Quota seats for MTech Environmental Engineering, each seat in Government Engineering College Thiruvananthapuram and Government Engineering College Thrissur for the candidates sponsored by Kerala State Pollution Control Board from the academic year 2022-23 onwards.

Government are also pleased to accord sanction for five Sponsored Quota seats for MTech Civil Engineering in any institution offering the



relevant specialization, for the candidates sponsored by Kerala Water Authority from the academic year 2022-23 onwards.

Accordingly, the Clause 3.2.1 and Clause 3.2.2 of the Prospectus for MTech Regular Course for the academic year 2022-23 is amended herewith as follows:

**Seats Reserved for Sponsored candidates (special reservation):-**

**3.2.1.** The following seats are reserved for MTech admission under sponsored candidates quota as per the existing Government orders.

### 3.2.2. Guidelines for Govt. sponsored candidates:

Maximum of 10% seats in each specialization is earmarked for the candidates sponsored by any other Central/State Govt. and Public sector undertakings on merit basis as per clause 6.3. The candidates should get the Government order from Higher Education Department for eligibility of such sponsorship. The Government orders in this regard should officially reach the office of Directorate of Technical Education on or before the last date of application. Maximum seats allotted for sponsored candidates should not exceed 10% in each branch/specialization of an institution. These candidates should fulfill the criteria of eligibility of admission clause 4.

The Government order read as 6th paper above stands modify to the above extent.
